ELECTRIC VEHICLE LEVEL 2 CHARGER



INCENTIVE PROGRAM

Kaukauna Utilities offers an incentive to encourage residential charging for electric vehicles (EV). If you are a homeowner with an electric vehicle, you may be eligible for a \$400 incentive toward a Level 2 electric vehicle charger.

Eligibility:

- Be a Kaukauna Utilities residential electric customer whose account is in good standing
- Have your electric vehicle charger installed on a electric meter billed under a KU residential electric service rate
- Own or Lease a registered vehicle that can receive a Level 2 charge
- Purchase and install a Level 2 EV charger on or after January 1, 2019
- Have your electric vehicle DOT registration registered and EV charger installed at your primary residence that is receiving electricity from Kaukauna utilities.

How to Apply:

- Applicant must meet all eligibility conditions and complete the application form (reverse side).
- Attach a receipt for the equipment and installation costs.
