
HEAT PUMP WATER HEATER (HPWH) REBATE PROGRAM

Incentive applications are available at the utility office or can be downloaded at **kaukaunautilities.com**.






SAVE ON YOUR ENERGY BILL WITH AN ENERGY STAR HPWH

HOW DOES A HEAT PUMP WORK?

- Heat pump pulls warmth from the air
- Warm air is compressed, increasing its temperature.
- Condenser coils transfer heat to the water

PROGRAM INFORMATION & REQUIREMENTS

PROGRAM REQUIREMENTS

- To qualify for an incentive, the applicant must meet all of the eligibility conditions and complete the incentive application on the right.
- Rebate is available to residential customers with a valid Kaukauna Utilities Electric Account.
- 3. HPWH products purchased must be installed at the electric utility account location.
- 4. Applications must be received within 6 months of the purchase date.
- IMPORTANT: The receipt or paid invoice must in-dicate the date of purchase, contractor name and address, brand, model number, price paid, and a copy of the Energy Guide or product manual with the Energy Star logo.

HOW TO RECEIVE YOUR REBATE

- 1. Complete the application form.
- 2. Attach the HPWH purchase receipt.
- 3. Include proof of product Energy Star designation.
