Customer Charge: \$16.00 per month – single phase \$25.00 per month – three phase	Energy Charge: \$0.1879 on-peak + PCAC \$0.0563 off-peak + PCAC
The on-peak period is 8:00am – 8:00pm, Monday through Friday.	

Small Power CP1 TOD

Customer Charge: \$50 per month	Distribution Demand Charge \$1.50 per kW of Distribution Demand
Demand Charge: \$9.00 per kW of billed demand	Energy Charge: \$0.0743 on-peak + PCAC \$0.0516 off-peak + PCAC
The on-peak period is 8:00am – 8:00pm, Monday through Friday.	

Except for RG3, the off-peak period is all the other times not shown as on-peak including Saturday and Sunday and the following holidays: New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day and Christmas Day. Further details on the next page.

Please note: Rates stated could change if Kaukauna Utilities files a rate application with the Public Service Commission of Wisconsin. All applicable taxes will be applied. All late payment provisions as stated in the Kaukauna Utilities rules remain in force. Once a customer begins service on this rate, that customer must remain on this rate for a minimum of one year. Any customer choosing to be served under an optional time-of-day rate waives all rights to billing adjustments arising from a claim that the bill for service would be less under any other rate schedule, or with different time periods than were selected. Once on this rate, the utility will review billing annually per Wis. Admin. Code Ch. PSC 113.

If a customer moves to a new location in the service territory, that new location is not subject to this time-of-day agreement. A new tenant at the above listed location would not be subject to this agreement.
