

### RATE SCHEDULE HOLIDAYS

New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, and Christmas Day, or the day designated to be celebrated as such.

### WISCONSIN STATE & COUNTY SALES TAX

All sales of electrical energy are subject to 5.5% sales tax. However, a law (§77.54(30)) was enacted in February 1979 providing a Sales and Use Tax Exemption for electricity sold for residential or farm use during the months of November through April.

### COMMERCIAL DISCOUNTS

#### For Customer Owned Transformers or Substations

Primary Metering Discount (energy):  
2,300 to 15,000 volts: 2%  
>15,000 volts: 3%

Service Voltage Discount (demand):  
2,300 to 15,000 volts: \$0.20/kW  
>15,000 volts: \$0.40/kW

### PROMPT PAYMENT OF BILLS

1% per month will be added to bills not paid within 20 days from the date of issuance. The late payment charge shall be applied to the total unpaid balance for utility service, including unpaid late payment charges. This charge is applicable to all customers.

### POWER COST ADJUSTMENT (PCAC)

\*All energy charges are subject to a positive or negative power cost, or fuel cost, adjustment charge equivalent to the amount by which the current cost of power (per kWh of sales) is greater or lesser than the base cost of power purchased and produced (per kWh sales). The base cost effective September 1, 2022 is \$0.0557/kWh.

Under provisions of 1999 Wisconsin Act 9, 2005 Wisconsin Act 141 and Wis. Stats. 16.957(5) and 196.374(7), a municipal electric utility shall charge each customer a low-income assistance and energy efficiency fee. 50% of the fees collected are used for low-income assistance programs and the remainder is used for energy efficiency programs.

#### Budget Payment Plan

Residential customers have the option to pay a fixed monthly amount throughout the year. KU calculates the amount based on average bills over the past year.

### Solar/Parallel Generation Rates

Customer Owned Generation Systems (20 kW or less) – PGS-1 – Net Energy Billing

Energy Charge Credit for kWh delivered to the utility. Charges per kWh are specified in the rate schedule under which the customer is served.

Customer Owned Generation Systems (>20 kW) – PGS-2

Energy Charge Credit for kWh delivered to the utility. Charges per kWh change annually to reflect the avoided cost rate supplied by WPPI Energy, the Utility's wholesale provider.

### TIME OF DAY SERVICE PRICING PERIODS

(Excludes RG-3)

**On-peak:** 8:00am to 8:00pm, Monday - Friday, excluding holidays

**Off-peak:** All times not specified as on-peak including all day Saturday and Sunday, and holidays.
