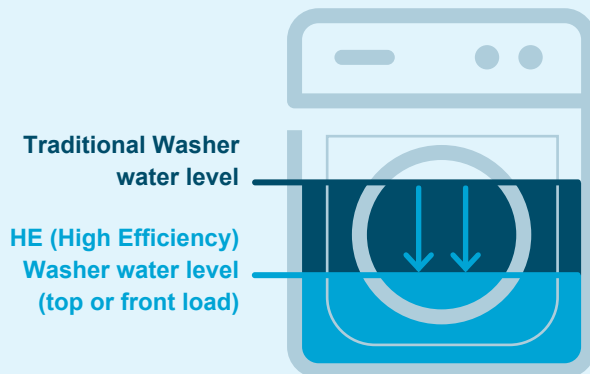
## HOW TO APPLY

1. Applicant must meet all eligibility conditions and complete application form.
2. **Applicant must pre-qualify to receive Whole Home Bonus.**
3. Attach receipts/proof that the equipment meets eligibility requirements.
4. Application must be received within 6 months of purchase date.

## PROGRAM REQUIREMENTS

1. Must be a residential KU water customer.
2. Appliance to be used at KU water account address only.
3. Appliance must be in new condition (not used or refurbished).
4. Kitchen Sink Faucet: Max flow rate of 2.2 gpm or less.
5. Bathroom Sink Faucet: WaterSense labeled. Max flow rate of 1.5 gpm or less.
6. Showerheads: WaterSense labeled. Max flow rate of 2.0 gpm or less.
7. Toilets: WaterSense labeled. 1.28 gpm/flush or less.
8. Clothes washer: Tier III required, Water Factor of 3.0 or less.
9. Dishwasher: Tier I required.
10. Water Softener: Demand Initiated Regeneration (DIR).
11. May not be combined with ENERGY STAR rebates.

## HOW TO RECEIVE YOUR REBATE

1. Fill out the rebate application.
2. MUST attach a copy of the original receipt/paid invoice.
3. IMPORTANT: The receipt/paid invoice MUST include:
  - Where purchased & Date of purchase
  - Brand, Model Number & price paid

Include **proof that item meets eligibility requirements.**
